We are so pleased that we were able to give them the opportunity to pick out special gifts for their Dads/Fathers/Father figures. The sale, as always, was a great success – thank you!

Sports Day – The PTA were very lucky to receive a donation of bottles of water, sourced by one of the Belmont parents. This meant that were able to provide the children with additional water during the sports day events.

End of year disco – As always the children really enjoyed the disco and it's lovely to see so many of them having a good old boogie! Thanks again to everyone that helped.

End of year treat – We always like to give the children a treat where possible and I think it is fair to say the lollies were greatly received.

Updates

Back to School Event – We have decided to run this on a Saturday, rather than a Friday evening, therefore it is planned for Saturday 21st September. This is predominantly an inflatables event, but we hope to run additional stalls doing games, tattoos and refreshments – dependant on the amount of volunteers we get. Since the new PTA took over in November 2018, we have raised over £4,000, which is a great achievement.

We have allocated funds to new core text books, helped with the setup of Forest School, donated the year 6 leavers T-shirts, invested funds in the setup of the gardening club, and provided the children with end of term treats. For the next academic year, we have already agreed to fund an anti-bullying workshop and we will be continuing to pay for the Panto, as the PTA has always done.

Without the support of Belmont parents/carers/extended family, we would not be able to continue running all the lovely, and sometimes vital, events for the children. We are aiming to build a Belmont community and we need you to be a part of it!
